Maximum Fees

- Standard Subdivision — **\$4,100** is the maximum fee for a final subdivision public report.
- Common Interest Subdivision — **\$7,600** is the maximum fee for a final subdivision public report.
- Time-Share Filing — **\$7,500** is the maximum fee for an original Renewed or Amended Public Report

Multiple Map/Phased Project

If you are applying for an overall preliminary public report for a multiple map or phased project, all interest fees (lots/units) must be included with the (initial) basic filing fee. (Not applicable to time-share or out-of-state registrations.)

You will only be required to pay the *basic filing fee* as you submit subsequent phases.

Payment Methods

Submit a cashier's check, money order or check payable to Department of Real Estate. Do not send cash.

Refer to Credit Card Payment (RE 909) for credit card payment information.

Attach and submit the filing fee or RE 909 with a photocopy of page 1 of the application.

HOW TO CALCULATE INITIAL FILING FEES

STANDARD SUBDIVISION

| | |
|---------|--|
| \$ 1500 | Final public report basic fee PLUS |
| \$ 15 | Per interest |
| \$ 500 | Additional fee for preliminary public report |

Example: Standard subdivision with 120 lots

| | |
|-----------|--|
| \$ 1500 | Basic fee |
| + \$ 1800 | \$10 per interest fee |
| = \$ 3300 | Total <i>without</i> a preliminary public report |
| + \$ 500 | Preliminary public report fee |
| = \$ 3800 | Total <i>with</i> a preliminary public report |

COMMON INTEREST SUBDIVISION

| | |
|---------|--|
| \$ 3000 | Final public report basic fee PLUS |
| \$ 15 | Per interest (including biennial interests) |
| \$ 500 | Additional fee for preliminary public report |

Example: Common interest subdivision with 60 units

| | |
|-----------|--|
| \$ 3000 | Basic fee |
| + \$ 900 | \$15 per interest fee |
| = \$ 3900 | Total <i>without</i> a preliminary public report |
| + \$ 500 | Preliminary public report fee |
| = \$ 4400 | Total <i>with</i> a preliminary public report |

TIME-SHARE FILING FEES

| | |
|---------|---|
| \$ 2500 | Basic fee plus \$15 per time-share interest. Time-share fee based on maximum allowable time-share interests (including biennial interests) for each original public report application |
| \$ 1500 | Renewal fee |
| \$ 1500 | Amendment fee |
| \$ 15 | Per time-share interest |

Maximum Fees

\$7500 per each original, renewal, or amended public report, regardless of the number of interests authorized to be offered for sale or lease. The \$1500 amendment (or \$1500 renewal fee, as applicable) will be waived in the amount excess of the maximum fee.

Only one amendment/renewal fee is necessary when adding time-share interests to multiple, previously approved locations.

HOW TO CALCULATE TIME-SHARE FILING FEES

Note: Examples are based on sales of 51 weeks per year per unit.

EXAMPLE 1

Initial application for 3 Locations in addition to 1 California Location: [Note: A fee reduction may be applicable to your project(s) under the following examples, which does not affect previously paid fees for previously submitted applications]

Location 1 Calculation

| | |
|-----------------|---------------------------------|
| \$ 2,500 | Basic fee |
| <u>\$ 9,180</u> | 612 time-share interests |
| \$ 11,680 | <i>over maximum; use \$7500</i> |
| \$ 7,500 | <i>Maximum fee *</i> |

Location 2 Calculation

| | |
|-----------------|--------------------------|
| \$ 2,500 | Basic fee |
| <u>\$ 2,295</u> | 153 time-share interests |
| \$ 4,795 | Total for location 2 |

Location 3 Calculation

| | |
|-----------------|--------------------------|
| \$ 2,500 | Basic fee |
| <u>\$ 7,650</u> | 510 time-share interests |
| \$ 10,150 | Total for location 3 |
| \$ 7,500 * | |

California Location 4 Calculation

| | |
|-----------------|--------------------------|
| \$ 500 | Basic fee |
| <u>\$ 3,750</u> | 250 time-share interests |
| \$ 4,250 | Total for California |

Final Calculations

| | |
|------------------|---------------------------|
| \$ 7,500 | For location 1 |
| \$ 4,795 | For location 2 |
| \$ 7,500 | For location 3 |
| <u>\$ 4,250</u> | For California location 4 |
| \$ 24,045 | Total fee |

EXAMPLE 2

Amendment adding time-share interests to 3 existing locations and adding 1 new location: [Note: A fee reduction may be applicable to your project(s) under the following examples, which does not affect previously paid fees. Also, the maximum filing fees charged for the addition of existing interests will be based on the total number of existing interests in all existing locations and the amendment fee, which are subject to the amendment. In addition, maximum filing fees for a new location(s) subject to the amendment will be considered separately. Finally, a RE 635C must be submitted for each existing location and a 668B for each new location]

Fees for Existing Locations

| | |
|-----------------|--|
| \$ 765 | Addition of 51 time-share interests to location 1 |
| \$ 5,355 | Addition of 357 time-share interests to location 2 |
| \$ 10,710 | Addition of 714 time-share interests to location 3 |
| <u>\$ 1,500</u> | Amendment fee |
| \$ 18,330 | <i>Total over maximum; use \$7500</i> |

Fees for New Location

| | |
|-----------------|---------------------------------|
| \$ 2,500 | Basic fee for new location |
| <u>\$ 9,180</u> | 612 time-share interests |
| \$ 11,680 | <i>over maximum; use \$7500</i> |
| \$ 7,500 | <i>Maximum fee</i> |

Final Calculations

| | |
|------------------|---|
| \$ 7,500 | Maximum fee for existing locations 1, 2, 3, and amendment fee |
| \$ 7,500 | Maximum fee for new location |
| \$ 15,000 | Total fee |

Fees for Existing Locations

| \$ 10,710 | Addition of 714 time-share interests to location 1 |
| \$ 12,240 | Addition of 816 time-share interests to location 2 |
| <u>\$ 1,500</u> | Amendment fee |
| \$ 24,450 | <i>Total over maximum fee; use \$7500</i> |

New California Location 3

| | |
|-----------------|--------------------------|
| \$ 500 | Basic fee |
| <u>\$ 3,750</u> | 250 time-share interests |
| \$ 4,250 | Total for California |

Final Calculations

| | |
|------------------|--------------------------------|
| \$ 7,500 | For existing locations 1 and 2 |
| <u>\$ 4,250</u> | For new California location 3 |
| \$ 17,750 | Total fee |
